I am to inform that the Ministry of Youth Affairs & Sports, Government of India has decided to use Public Finance Management System (PFMS) to cover all transactions and payments under Central Sector Schemes (CSS) for processing of payments, tracking, monitoring and reporting of funds utilization. As per the instructions received from the Ministry as well as from the NSS Regional Directorate, Chennai, the Grant (75%) for the year 2018-19 for both Regular Activities and Special Camping Programme are released to the Universities and Directorates as indicated in the tabular column.

Accordingly, the Tamil Nadu State NSS Cell and NSS Regional Directorate, Government of India have taken necessary steps and registered all the details pertaining to NSS Cells of Universities and Directorates under PFMS. Each University and Directorate has entered only one SB Account Number during PFMS Registration and the same is intimated to State NSS Cell. The Tamil Nadu State NSS releases the Total Grant (for both Regular and Special Camping programme) to that SB Account Number ( Programme Coordinator, NSS Regular OC Account) of Universities and Directorates through PFMS. However, the Programme Coordinators can maintain the Regular Accounts and Special Camp Accounts in Cash Books separately as

It is informed that the NSS Grant for the year 2018-19 has been released in total to all the Universities / Directorates in Regular OC Account Number. It is requested that the total grant need to be re-distributed to Regular Activities ( OC, SC and ST categories ) & Special Camping Programme ( OC, SC and ST categories) as shown in the above Tables 1 & 2.

The Government of India changed the pattern of release of grant for both NSS Regular and Special Camping Programme from the year 2011-2012 on the basis of (OC / SC / ST) categories and accordingly the funds are being released.   - d. Further the Programme Coordinator, NSS of Universities / Directorates must release the grant to the NSS Units of their affiliated Colleges / Institutions for Regular Activities and Special Camping Programme under category wise through PFMS immediately.

2. **The Grant sanctioned shall be subject to the following:-**

1. Internal Audit by the State NSS Cell of the Directorate of Collegiate Education, Chennai.
2. Audit of Accounts by the NSS Regional Directorate, Shastri Bhavan, Chennai.
3. Audit of Accounts by the Department of Local Fund Audit, Govt. of Tamil Nadu.
4. Statutory Audit by the Accountant General.

The Programme Coordinator, NSS of Universities / Directorates are requested to incur expenditure as per above guidelines and Government Order and ensure that no expenditure is incurred towards any Programme contrary to NSS Activities by diverting NSS funds without specific approval of the State Coordinator, NSS.

**The Programme Coordinator, NSS of Universities / Directorates are requested to release the funds through PFMS for Special Camping Programme and Regular Activities immediately so that the Colleges / Institutions will complete the programmes by utilizing the fund before 31<sup>st</sup> March,2019.**

- There should not be any diversion of funds from the Regular Activities to Special Camping Programme viz. versa under any circumstances.

d. Further the Programme Coordinator, NSS of Universities / Directorates must release the grant to the NSS Units of their affiliated Colleges / Institutions for Regular Activities and Special Camping Programme under category wise through PFMS immediately.



- d. Further the Programme Coordinator, NSS of Universities / Directorates must release the grant to the NSS Units of their affiliated Colleges / Institutions for Regular Activities and Special Camping Programme under category wise through PFMS immediately.


**2. The Grant sanctioned shall be subjected to the following:-**


