At the outset the curriculum and syllabus is observed to be well done and appreciated.

The following were the suggestions recorded by the panel members present at the BOS meeting held on 08.06.17. The core papers and elective papers are analyzed meticulously and interchanged accordingly.

- . The Head of Department (Dr.Sumathy Eswaran) initiated with detailing the syllabi to the
- Dr. Yogesh (Anna University) clarified on the restrictions applied for Technical skills.
- · Mr.Raghunathan (National Informatics Centre) insisted on the evaluation methods of Technical skill certification by the students, also recommended the duration of Inplant training could be atleast 3 months. He also appreciated the classification of Electives according to SMAC(social Mobile Analytics and cloud). Also ladded a point to include Content Management system and Secured Programming in the curriculum.
- . Dr . Yogesh (Anna University) suggested title for the elective Fundamental of Mems to IOT or Building IOT and renaming of Perl, Phython, Ruby under common frame work.
- Dr.N.Sadagopan(Alumni/IIIT) spotted his suggestions from the syllabus of Data structures and algorithms. He claimed to include Algorithmic analysis and Asymptotic notations in the syllabus and to exclude 5 th unit Design Methods for UG level as it will take 20 hours exclusively.
- Mr.Muruganantham insisted upon Java Programming being taught early. Also he suggested to combine the course Object Oriented analysis and Design with Software Engineering . Hence a course and syllabus for Object Oriented Software Engineering is framed.Further he suggested to include Enterprise Architecture and Machine Learning.



Board of Studies Minutes

The Board of Studies Meeting for B. Tech (CSE) was held on 19.4.2018. There is no change in the syllabus, only the curriculum has been redefined as per AICTE Guidelines.

The following points were discussed for redefining the curriculum

- Regulation 2018 is framed on the basis of AICTE Regulation 2018, in which the major revision is done on the number of credits to be carned for the award of B.Tech degree. The new revision proposes 160 credits. Based on the AICTE / our Framework the required subjects to be finalized.
- The flow of the core papers and the structure of the curriculum is satisfactory
- The first year (Semester 1 & 2) subjects remain common for all engineering
- Soft skills 1 & 2 offered in Semester 4 & 6.
- Technical Skills 1, 2 & 3 (evaluation) offered in Semester IV, V and VI
