After detailed discussion the following resolution passed in the meeting;

1. Implementation of New Curriculum (CBME) as per the new GMER guidelines was discussed and approved.
2. According to the CBME, the syllabus was discussed in detail under the new regulation of the Board of Governors (suppression of MCI) and the same was accepted by all the members
3. The Aim, Goal, Objectives, Skills, Integration, Attitude and Communication were finalized.

4. The competencies for theory, practical, small group teachings, self directed learning, integration and tutorials were demarcated along with the teaching learning methods and the number of hours.
5. Topics to be covered in Paper I and Paper II for each subject was finalized.
6. Topics was separated as Core and Noncore as per NMC guidelines
7. Regular periodic examinations shall be conducted throughout the course. There shall be no less than three internal assessment examination in each preclinical subjects.
 - a. The average of the theory internal assessment marks will be calculated for 40 marks to which 10 marks for continuous formative assessment will be added giving a total of 50.
 - b. The average of the practical examination will calculated for 40 marks to which 5 marks for Skill certification and 5 marks for record will be added giving a total of 50
8. Learners must secure atleast 50% marks of the total marks (combined in theory and practical, not less than 40% marks in theory and practical separately) assigned for internal assessment in a particular subject in order to be eligible for appearing at the final University examination of that subject.
9. Learners must have completed the required certifiable competencies for phase I and completed the log book. Log book to be designed incorporating the certifiable skills.
10. **University Examination**
 - a. The first professional examination shall be held at the end of first professional training (12 + 1 months) in the subjects of Anatomy, Physiology and Biochemistry.

b. Eligibility criteria to appear for University examination

- i. Attendance – 75% in theory and 80% in practicals
- ii. Internal assessment - Learners must secure atleast 50% marks of the total marks (combined in theory and practical, not less than 40% marks in theory and practical separately) assigned for internal assessment in a particular subject in order to be eligible for appearing at the final University examination of that subject.

c. Pass criteria for University examination

Learner must secure at least 40% marks in each of the papers with minimum 50% of the marks in aggregate (both papers together) to pass in the said subject.

- d. Internal assessment marks are not to be added to marks of the University examinations and should be shown separately in the grade card.

1. Under the curriculum for II.MBBS(2019 – 2020 Batch) Under the new regulation of the board of governors(Suppression of MCI) the aim , goal, objectives, skills, integration , attitude and communication were finalized .
2. The competencies for theory, practical, small group teachings, self directed learning, integration and tutorials were demarcated along with the teaching learning methods and the number of hours.
3. Topics to be covered in Paper I and Paper II for each subject to be listed down.
4. Topics to be separated as Core and Noncore topics.
5. Examination pattern including maximum marks for Theory/ Practical/Viva
6. Internal assessment
 - a. 3 internal assessments including model exams will be conducted for both theory and practicals.
 - b. Total marks for theory will be 100 marks
MCQs - $20 \times 1 = 20$
Structured Essay – $2 \times 10 = 20$
Short notes – $8 \times 5 = 40$
Ultra Short notes – $10 \times 2 = 20$
 - c. The average of the 3 internal assessment marks will be calculated for 40 marks to which 10 marks for formative assessment will be added giving a total of 50.
 - d. The details for the conduct and the mark distribution of the formative assessment were framed.
 - e. Total marks for practical examination will be 40 marks, 5 marks for Skill certification and 5 marks for record will be added giving a total of 50
 - f. The details for the conduct and the mark distribution for practical examination were framed.
7. Guidelines to be framed for Question paper setters.
 - a. All MCQs should be from core topics
 - b. All Essays should be from core topics

A candidate shall obtain 50% marks in University conducted examination separately in Theory and Practical (including practical and viva voce) in order to be declared as passed in that subject
 - c. Internal assessment marks are not to be added to marks of the University examinations and should be shown separately in the grade card.
10. In subjects that have two papers the learner must secure at least 40% mark in each of the papers with minimum 50% of the marks in aggregate (both papers together) to pass in the said subject.
11. Question paper validity will be done by subject experts
12. A learner, who fails in the second professional examination, shall not be allowed to appear in Third Professional Part I examination unless he/she passes all subjects of second Professional examination
