The Agenda items for the meeting was presented and discussed

The Indian Nursing Council (INC) Circular with regard to strict adherence to the Scheme of Examination was circulated and discussed (F.No.22- 10 /Univ.-2019-INC) . **Agenda 1**

**Integration of the Concept, Roles and Responsibilities of "Middle Level Health Provider" (MLHP) and Log book** prescribed by Ministry of Health and Family Welfare in the subject Community Health Nursing – II in 4<sup>th</sup> Year B.Sc.
