- In order to increase the employability of the B.Pharm graduates, the council has recommended that
 - a) The student / institution may choose one of the elective subjects from the skill packs/modules of LSSSDC as their elective subject in B.Pharm (Semester VIII) curriculum. The university shall give necessary credit for the same in the award of marks and as a requirement fulfilled as against the elective subject to be studied by the student for the award of the Degree of Bachelor of Pharmacy.
 - b) The student has the choice to choose both the elective subjects from the already prescribed list of elective subjects by the PCI or choose one elective subject form the existing prescribed list of elective subjects of B.Pharm programme by the PCI and the another (second) elective from list of skill pack/modules available with the LSSSDC from time to time.
