12/1/2021

Dr. Karthikeyan Principal, chaired the meeting and welcomed all the members to the first BOS meeting of the year 2021. All the heads and other members welcomed Dr. Karthikeyan as the new principal of the dental college.

#### AGENDA 1

Principal emphasized the need for a short-term fellowship in dentistry and everybody seconded the idea and welcomed the new move.

Dr. Krithika proposed that all the clinical departments namely, Oral surgery, periodontics, Orthodontics, Prosthodontics, Pedodontics and conservative dentistry should take actively take part and discuss the proposed syllabus.

Dr. Pradeep said that the goal of the program was to empower the candidates with clinical skills which will enable them to practice general dentistry with confidence. He suggested that the students should go on rotation basis to all the clinical departments.

Dr. Ponsekar discussed in detail the clinical and preclinical prosthodontic curriculum that would be imparted to the candidate during their clinical posting. Other heads also proposed the syllabus, both theory and clinical with regards to Periodontics, Restorative dentistry, Oral surgery, Pedodontics and Orthodontics.

Decisions regarding evaluation pattern of theory and clinical skills was also discussed and it was agreed uniformly that it should be done at the end of the year as a comprehensive assessment.

Principal read out the proposed syllabus to all and everyone concurred with the

same. Thereafter, it was unanimously decided to forward the proposal to the academic council of the university for ratification.

#### AGENDA 2

Attention was brought to the tentative/suggested schedule proposed by DCI. The new first year BDS students, who joined college in the academic year 20-21, will have the following schedule regarding completion of every year. It was proposed to follow the schedule given by DCI. (ANNEXURE II attached)

Principal urged all the heads to take note of this and finish the academic programme by July so that the examinations could be accommodated well within the proposed schedule.

Questions were raised for the present Interns and as to when they would complete. Principal stated that according to DCI proposal (ANNEXURE II), the 2016-17 batch should have their postings from Jan 21 to Dec 21 and they would complete their internship by December 21.

#### AGENDA 3

Principal updated the status regarding the relaxation for submission of dissertation thesis by PG Students admitted during the Academic year 2019-2020.

- In view of the COVID 19 pandemic the DCI has decided to relax the said portion of the regulation and allow the Postgraduate degree students of batches 2018-19, to submit their thesis at least three months before the Theory and Clinical/Practical examination.
- Further, in view of dearth of clinical material during current COVID 19 pandemic, the Universities and Dental colleges/institutions are also advised that while evaluating the thesis submitted for acceptance for the batches 2018-19, final sample size actually analyzed may be considered even if it is less than the committed sample size in the approved thesis protocol for the study

Decisions regarding the SOP was also discussed. Principal stated that all the measures taken till date will continue which were the following

- 1. Physical distancing of at least 6 feet to be followed
- 2. Use of face covers/masks to be made mandatory
- 3. Use of alcohol-based hand sanitizers/soap
- 4. Respiratory etiquettes to be strictly followed
- 5. Regular screening of faculty, staff and student

Principal asked all the Heads to urge students to download and use the Aarogya Setu App.

Questions were raised regarding the teaching method to be followed. Principal clarified that as of now, online teaching to be done and simulation teaching and objective structured clinical practical training methods, case-based learning and problem-based learning should be incorporated in the teaching learning modules.

With the above discussion, Principal expressed his gratitude to all the members present for active discussion and valuable suggestions regarding the fellowship program proposal and the meeting ended.
