- vi. Your office timings are between 10.00 A.M and 4.00 P.M. This may extend depending on the projects on hand
- vii. You will not be entitled to any allowance / payment from the project fund unless specifically stated possible if you are selected by a regular Appointment Committee
- viii. You should also follow the ideas and suggestions of the higher Officials / Management and you would abide by the rules and regulations of the University
