SECTION – D

209.0 REGULATIONS FOR B.SC COURSES UNDER ALLIED HEALTH SCIENCES

210.0 SHORT TITLE AND COMMENCEMENT :

These regulations shall be called as **"B.Sc DEGREE COURSES UNDER ALLIED HEALTH SCIENCES"** of the Dr.MGR Educational and Research Institute & University, Chennai.

They shall come into force from the academic year 2017 – 2018.

The regulations and syllabus are subject to modification from time to time by the Academic Council.

211.0 OVER ALL OBJECTIVES

The **B.Sc DEGREE COURSES UNDER ALLIED HEALTH SCIENCES** are prepared with the objective of assisting the Doctors for providing Quality Patient Care in selected areas of Clinical Specialty in the Hospital and Community.

212.0 ELIGIBILITY FOR ADMISSION:

"A Pass in 10+2 with Physics, Chemistry & Biology subject or an equivalent with 12 years of schooling from a recognized Board of University with minimum 35% marks in each subjects separately including English for all Categories.

213.0 AGE LIMIT FOR ADMISSION:

A candidate should have completed the age of 17 years at the time of admission or would complete the said age on or before 31^{st} December of the year of admission to the **B.Sc. DEGREE COURSES UNDER ALLIED HEALTH SCIENCES.**

214.0 ELIGIBILITY CERTIFICATE :

The candidate who has passed any qualifying examinations other than the Higher Secondary Course Examination conducted by the Government of Tamil Nadu, before seeking admission shall obtain an Eligibility Certificate from thus University by remitting the prescribed fees along with application form.

215.0 COMMENCEMENT OF THE COURSE :

The course shall commence form 1^{st} September of the academic year.

216.0 MEDIUM OF INSTRUCTION

English shall be the Medium of Instruction for all the Subjects of study and for examinations of the **B.Sc DEGREE COURSES UNDER ALLIED HEALTH SCIENCES.**

217.0 CURRICULUM

The Curriculum and the syllabus for the course shall be as prescribed in these regulations are subjects to modification s by the Academic Council from time to time.

218.0 DURATION OF THE COURSE :

The duration of certified study for the **B.Sc DEGREE COURSDES UNDER ALLIED HEALTH SCIENCES** shall extend over a period of four academic years including one year internship.

218.2 The candidate should complete this course in 6 years from the date of joining the course.

219.0 RE - ADMISSION AFTER BREAK OF STUDY :

The regulations for re – admission are as per the University Common Regulation for Re –Admission after break of study for all courses.

220.0 WORKING DAYS IN THE ACADEMIC YEAR :

Each academic year shall consist of not less than 240 working days.

221.0 ATTENDANCE REQUIRED FOR ADMISSION TO EXAMINATION :

- 221.1 No candidate shall be permitted to appear in any one of the parts of **B.Sc DEGREE COURSES UNDER ALLIED HEALTH SCIENCES** Examinations unless he / she has attended the course in the subject for the prescribed period and produce the necessary certificate of study, attendance and satisfactory conduct from the head of the Institution.
- 221.2 A candidate is required to put in a minimum of 75% of attendance out of 240 working days in theory in each subject before admission to the examinations except for 1st year candidates whose attendance will be counted from the date of joining. **The academic year should consist of not less than 240 working days.**
- 221.3 (c) A candidate must have 75% attendance in each of the Practical / Clinical areas before the award of Degree.

222.3 CONDONATION OF LACK OF ATTENDANCE :

There shall be no condonation of lack of attendance.

223.0VACATION

15 days in the month of December and 15 days in the month of May.

224.0 INTERNAL ASSESSMENT MARKS :

- 224.1 The internal Assessment should consist of the following points for evaluation :
 - j) Theory
 - k) Practical / Clinical

l) Viva

224.2 A minimum of three written examinations shall be conducted in each subject during a year and the average marks of the three performance shall be taken into consideration for the award of Internal Assessment marks.

224.3 A minimum of one practical examination shall be conducted in each subject (wherever practical has been included in the curriculum) and grades of ongoing clinical evaluation to be considered for the award of Internal Assessment marks.

225.0 CUT-OFF DATES FOR ADMISSION TO EXAMINATIONS :

225.1 30th October of the academic year concerned.

225.2 The candidates admitted upto 30^{th} October of the academic year shall be registered to take up the 1^{st} year examination during September of the next year.

All kinds of admission shall be completed on or before 30th October of the academic year. There shall not be any admission after 30th October even if seals are vacant.

226.0 COMMENCEMENT OF THE EXAMINATIONS :

1st September / 1st March

226.2 If the date of commencement of examination falls on Saturdays / Sundays or declared Public Holidays, the examination shall begin on the next working day.

227.0 MARKS QUALIFYING FOR PASS :

50% of marks in the University Theory Examinations

50% of marks in the University Practical Examinations

50% of marks in the subjects where internal evaluation alone is conducted

50% of marks in aggregate in Theory, Practical I.A & Oral taken together

228.0 CARRY OVER OF FAILED SUBJECTS

- 228.1 A candidate has to pass in theory and practical examinations separately in each of the paper
- 228.2 If a candidate fails either in theory or practical examinations, he/she has to reappear for both (theory and practical)
- 228.3 The candidate has to successfully complete the course in double the duration of the course form the date of joining (i.e. 6 years from the date of joining This will be implemented from the Academic Year 2017 18 onwards

228.4 Carryover of Arrears are allowed

- 228.5 Those who have failed in the 1st year can attend the 2nd year classes and appear for re-examinations.
- 229.0 PRACTICAL EXAMINATION :
- 229.1 Maximum number of candidates for practical examination should not exceed 20 per day
- 229.2 An examiner should be a lecturer or above in any of the affiliated institutions of Allied Health Sciences.
- 230.0 NUMBER OF EXAMINERS : One internal and one external examiner should jointly conduct practical / oral examination for each student
- 231.0 RETOTALIING OF ANSWER PAPERS : Retotalling of answer papers is permitted on request along with the prescribed fees.
