NOTIFICATION

In exercise of the powers conferred by Section-3 of the University Grants Commission Act, 1956 (3 of 1956), the Central Government, on the advice of the Commission, has declared Dr. M.G.R. Educational and Research Institute, Chennai comprising of the following two institutions as Deemed to be University for the purpose of the aforesaid Act with effect from 21st January, 2003 subject to a review after 3 years vide its Notification No. F.9-1/2002-U.3 dated 21st January, 2003.

- I) Thai Moogambigai Dental College and Hospital, Chennai; &
- II) Dr. M.G.R. Engineering College, Maduravoyal, Chennai.

*The grant of provisional status of Deemed to be University to **Dr. M.G.R. Educational and Research Institute, Chennai** is subject to the conditions that;

- (i) It will adhere to the guidelines/instructions issued by UGC & AICTE from time to time as applicable to the Deemed Universities;
- (ii) The institute will start:-
 - a) PG programmes in all major departments and augment its research activities and industry linkages;
 - b) Apply, obtain and pursue a few R & D project funded by Government S & T Departments/Agencies;
 - c) Set up an effective industry-institution interaction to facilitate improved campus placement and consultancy activities;
 - d) Launch a vibrant faculty development programme;
 - e) Strengthen the basic science departments to encourage PG education and research in basic science; and
 - f) Introduce courses in "Entrepreneurship" for UG/PG students to be in line with its mission of educating the job creators.

Chennai – Recommendations of the review committee for
continuation of Deemed-to-be-University status – reg.

Sir,

I am directed to inform you that on the basis of the report of the review committee which visited your Institution on 22-23rd February, 2007, the Commission has sent its recommendations for continuation of your Institute as Deemed-to-be-University to Ministry of Human Resource Development, Government of India for their consideration. While recommending for continuation of the status of Deemed-to-be-University, the committee has also given the following suggestions :-

Dr. MGR Engineering College

- The faculty members should make sincere and rigorous efforts to get financial assistance for R & D activities from various funding agencies as well industry.
- The committee observed that the Deemed University has started various off-campus centers across the country without the approval of UGC. The UGC may immediately send a directive to the Deemed University to take necessary and immediate steps to apply as per the guidelines of the UGC for seeking the approval of off-campus centers.
- Hand on experience and project work should be encouraged among the students. They may also be provided 'Seed Money' for taking up some innovative programmes.
- Add-on courses for students may be started to enhance communication skills.


- The placement and counseling cell should be strengthened. Companies should be invited for campus placements in all the disciplines.

Thai Moogambigai Dental College

- The dental college (Constituent unit) should take immediate steps to start PG courses for which the development of physical and academic infrastructure should be taken up on priority basis.
- The faculty should take independent research work in dentistry by making use of facilities available in the Engineering college as lot of dentistry is material based.
- Effort should be made for collaboration with the foreign universities as has been done in case of Engineering College.
- Starting of new specialized courses like DNB and dental implantology.

You are requested to submit the compliance report in respect of the suggestions given by the expert committee, at the earliest.
