#### MINUTES OF THE MEETING

- ❖ A complete list of resolutions of the previous IQAC meeting & actions taken on them were highlighted by Dr. P. Udhayakala, Director of IQAC in a brief power point presentation.
- ❖ The salient features of the PPT are highlighted below.
  - i. The proposal by Dr.V.Cyril raj, Joint Registrar Academics, on FDPs through NPTEL certificate courses, is proposed as an agenda and will be taken up for discussion in the present meeting.
  - ii. Dr. Balachandran's (Director Admin) proposal to form Quality Circles have been given shape. Three quality circles for three broad areas of study have been created.
  - iii. The lead role of nucleation in faculty maturation was taken up by the IQAC by arranging a learning session on Advances in Pain Medicine conducted by Dr. Pradeep Dinakar, Director, Interventional pain medicine, Harvard Medical School at ACS Medical College and Hospital on 9.08.19.
  - iv. One of the UGC Quality mandate is to encourage learning on the lines of Outcome Based curriculum frame work. An attempt to give shape to this quality mandate was made by organizing a workshop on "Attainment of student performance & learning outcomes" on 16.08.19 by Dr. N.S. Subhashree, Dean (E&S).
  - v. Scheme for Trans-disciplinary research for India's Developing Economy (STRIDE) is being given added impetus by UGC in the current dispensation which insist on MoU between the participating institution.
  - vi. To translate the above idea into actual practice an MOU was signed with SpARC (Spiritual Application Research Centre)
  - vii. Under the MOU a seminar was organized on "Quality improvement through spiritual healing. Mr. Naresh Gupta (IAS Retd), Sister Neelima, Zonal coordinator SpARC and Sister Beena, Service coordinator, Brahma kumaris, South zone, enlightened the faculty members with inner engineering techniques.
  - viii. As a part of MoU, an initiation into value education was imparted to the students of the first year B.Tech course by Mr.Balaji from SpARC. This is in line with the UGC regulations to conduct a student induction programme for freshers under the head Deeksharambh.

- ❖ Dr.S. Geetha lakshmi, Pro Vice Chancellor of the University hailed the IQAC team for their dedication and highlighted the pivotal role of IQAC in raising and upholding the prestige of the University. She opined that premier institutions like IITs and IISc dominate the hosting of NPTEL courses. But, faculty members of our University can emulate premier institutions by conceptualizing and hosting novel courses in the NPTEL portal.
- ❖ Dr. Sridevi, IQAC (i/c) presented the departmental IQAC minutes for Medicine, Pharmacy, Physiotherapy, Nursing, Dental, Management Studies, Humanities & Science.
- ❖ Dr. Kanya , IQAC (i/c) presented the departmental IQAC Minutes of the faculty of E&T, Architecture and Hotel Management and Denovo Courses.
- ❖ Dr. Rama Vaidyanathan, Director of Research, congratulated the Dept. and the faculty who have applied for funded projects. The outcome of the applications is awaited. She sought the feedback of faculty to encourage more applications for grants and better outcome in funding.
- ❖ One suggestion given by the Research Scrutinising Committee of the University was to make it mandatory for each Dept. in the University to ensure that atleast 10% faculty apply for atleast one project each Semester for an open call. Dr. Viji vinod, HoD, Department of Computer Application concurred with the suggestion.
- ❖ Dr. Manoj, Prof. of Psychology wished that in-house financial support may be provided to worthwhile projects after scrutinizing it through an expert team.
- Providing financial incentives for faculty members who submit more than two applications, would be a motivating factor for others, felt Dr.J. Sridevi IQAC (i/c)
- ❖ Ms.Tamilselvi, Prof., Department of CSE, felt that modifying workload pattern is necessary for encouraging research.

- ❖ Dr. Malini Pande, Joint Registrar (H&S/ Academics) felt that the number of research projects submitted for funding will give a positive impact to the University and hence it must be given priority.
- ❖ Dr.P.Udhayakala, Director-IQAC expressed that the research supervisors should encourage their scholars to submit project proposals.
- ❖ Dr. T.Johnson, HoD Mathematics suggested that project associates be appointed with the main objective of applying for funded projects.
- ❖ Dr. Rama Vaidyanathan, announced that the University is releasing a booklet on Stories of Innovation in the campus on the Birthday of Dr. A.P.J Abdul kalam. She requested the faculty members to contribute articles on innovative teaching methodologies.
- ❖ Dr. Rama vaidhyanathan wished that a special paper on intellectual property rights can be added to the curriculum.
- ❖ Industry invitee Ms. Lakshmi priya, Manager Rane Group (Industrialist), wished that the research projects should have industry relevance so that they can be patented. She also expressed a need for an unit in the University which would bridge gap between the industry and institute.
- ❖ Dr. Malini Pande replied that the university already has an active Industry − Institute partnership cell which contributes in framing the curriculum/syllabus and arranging internships/industry training.
- ❖ The Industry invitee was very particular about redesigning courses to make students Job-Ready.
- ❖ An alumni, Ms. Yogalakshmi, felt that online courses can never be a total substitute for class rooms and that such online courses can only add value to basic degree courses.
- On the other hand, Mr. Boopathy Rajan, the student representative, felt that online courses are more convenient and beneficial.
- ❖ Dr.T. Johnson, Head Digital learning, felt that teachers may not be replaced by digital learning and a facilitator is needed in education.

- ❖ The Parent representative, Ms. Bindu Jayamohan was very happy about the deliberations which centered around imparting education, values and skill to the students.
- The Professor of Psychology, Dr. Manoj, suggested that the induction programme may be made mandatory for all streams as required by UGC.
- ❖ Dr. P. Udhayakala, Director IQAC assured that steps will be taken to implement this idea through the Deans of the respective faculties.
- ❖ Mr. K.K. Sridev, Dean (i/c), Head, Faculty of Law, a new faculty added to IQAC of the University expressed their cooperative and supportive nature towards the growth of the University.
- ❖ The Director of IQAC thanked all the participants for their valuable ideas.
